**Crossing the Ethical Boundary: Insights from a Fraud Investigator**

**Program Content:** In this session, BKD Forensics Director Sean Sarsfield CPA/CFF, CFE, CVA will be focusing on several examples of individuals that have crossed the ethical boundary. He will also be sharing insights into, and examples of, ethical issues observed in fraud investigations and discussing decision making in ethical dilemmas.

Learning Objectives: After this presentation, participants will

- Learn the traits of a typical fraudster.
- Understand recent fraud related trends based on the most ACFE Report to the Nations.
- Identify of some of the various tools that fraud examiners use during their investigations. Establish a more detailed understanding of how to account for CARES Act funding.

**Sean Sarsfield** is a Director with BKD's Forensics & Valuation Services division and leads its Houston forensics practice, providing forensic accounting, fraud investigation, insurance claim and litigation support related services. In addition to being a CPA, Sean has the following accreditations: CVA (Certified Valuation Analyst), CFF (Certified in Financial Forensics), and CFE (Certified Fraud Examiner). For over twenty years Sean has provided advice to attorneys, executives, and shareholders to assist them throughout the dispute process. He has extensive experience guiding his clients through the duration of the legal process, from initial fact gathering and discovery through arbitration, mediation, and trial. Prerequisites and advance preparation are not required unless otherwise indicated. Depending on the track the participant attends, a maximum of 8.0 CPE credits is available. All courses are instruction method: Group Internet Based All sessions will incorporate an element of participant engagement, and there will be time for questions after each session.

CPE Type is classified based on NASBA definitions. The Arkansas State Board of Public Accountancy recently received final approval for the following CPE rule changes: Those working in public accounting must obtain 40% of their hours in content areas of Tax, Accounting & Auditing, and Ethics. Those not working in public accounting are required to obtain 20% of their hours in Tax, Accounting & Auditing, and Ethics. Previously, all active CPAs were required to obtain 50% hours in the specified subject areas. Finally, the Board reduced the group-study CPE requirement from 16 hours to 8 hours per year. These CPE changes are effective retroactive back to January 1, 2020. Chapter leadership is aware of these changes and committed to helping our CPA members meet the requirement each year by providing as many hours as possible in the specific categories listed above at each of our meetings, including annual MidSouth meeting and December CPA-Focused meeting.
