Alese, Rhonda and Phyllis met in Vistage, a peer advisory group for executives. They were the only women in the group, so the bond was instant. They had no experience with any aspect of podcasting when they launched this venture, yet have mastered enough new skills to have published over 45 episodes to date (far longer that the average new podcast).

**Rhonda McKinnis** is an attorney with a long-running track record of wins in complex litigation, public service as an assistant attorney general, and as general counsel to hospitals, health systems, and universities. She currently lives in Texas and is in-house counsel to a health care system.

**Phyllis Rogers** has over 30 years of experience as a CPA and over 20 years of experience as a CFO. She currently serves as CFO of the Arkansas Foundation for Medical Care.

Alese Stroud is a serial entrepreneur. She has decades of FinTech experience having consulted with some of the largest banks in the nation. She is currently managing a portfolio of self-storage facilities and co-founding StorageTrader, a platform for facilitating fractional investment in self-storage facilities.

During the deep winter of COVID confinement, the three of us maintained our sanity with regular Sunday evening Zoom conversations.
